Cable Air Faire 2015 celebrates its **40th annual** event. We are going to dedicate this event to Cable Airport as it celebrates its **70th anniversary**. Put your imagination to work as we go back in time 70 years . . .

The **Southern California home front during World War II** supported the war effort in many ways, including a wide range of volunteer efforts and submitting to government-managed rationing and price controls. Everyone agreed that the sacrifices were for the national good "for the duration." Millions of students, retirees, housewives, and unemployed moved into the active labor force. Hours worked increased as leisure activities declined sharply. Most families were allocated only 3 gallons of gasoline a week, which sharply curtailed driving for any purpose. Production of most durable goods, like cars, new housing, vacuum cleaners, and kitchen appliances, was banned until the war ended. In industrial areas housing was in short supply as people doubled up and lived in cramped quarters. Prices and wages were controlled. Americans saved a high portion of their incomes, which led to renewed growth after the war.

During this this time, Dewey and Maude Cable had moved to Southern California from Iowa to be farmers. Dewey's brother, John, was a pilot. He was considered a barnstormer, flew air mail for the Postal Service and he was a test pilot for Douglas Aircraft. John got Dewey up in the air in the '30s and that's all it took. Dewey fell in love with aviation, and so did Maude. A few years later, 1945 to be exact, Dewey carved out a couple of runways on some open land in what is now known as Upland. The rest is history....

Come join us for a celebration of days gone by as we take you back to 1945. If you appreciate the days of the greatest generation, where our country was truly united, when neighbors knew and helped each other out, and this nation proved itself to be the greatest in the world, then we invite you and your family to actively participate in this year's celebration at Cable Airport.

We are proud so many of Cable Airport's tenants and friends choose to help support this event and we are asking for you to do it again. If you own a pre-1950 vintage aircraft, or have a friend you can share this information with, we invite you to either display it or do flight demonstrations (flybys) during the event.

In order to coordinate the display area and flight demonstrations, a Special Interest Aircraft Registration is required to be filled out and returned to us. For your convenience, I am enclosing information and the form.

SPECIAL INTEREST AIRCRAFT REGISTRATION INFORMATION

All aircraft wanting to participate in Cable Air Faire 2015 must fill out the attached SPECIAL INTEREST AIRCRAFT REGISTRATION FORM and be assigned a "Registration Number".

NOTICE: There will be a TFR in place as well as temporary **Air Traffic Control Tower** both Saturday and Sunday.

DISPLAY ONLY

The Cable Air Faire has had a challenge in past years with limited room for display aircraft parking. This coming year, we will be moving our aircraft display area to the large South tarmac which lies West of the café. This will allow many more aircraft to attend and display than in past years. Please fill out the form to reserve a parking spot for your plane during the Cable Air Faire 2015.

Static display aircraft, should arrive prior to noon on Friday and may be blocked in with other aircraft until after the show on Sunday, this is due to limited parking. We no longer will be allowing daily fly-in aircraft to park on the south side of the airport. Display aircraft will be assigned parking for each aircraft. The number will be written with side walk chalk, where the aircraft will be displayed. Please bring your own chocks, or tie downs.

Approved static display aircraft will be eligible for two display days at Cable Air Faire-2015. (Regulations on tax exempt status, and if your aircraft meets that requirement can be found at your county's tax collector office, or online at their official site.)

Aircraft will be on static display at the Air Faire for public inspection. Enhanced security procedures will also be in place.

For Display Aircraft, admission fees will be waived for the pilot & co-pilot. All other guests on-board the aircraft will be required to purchase a General Admission ticket. Please check in with the Information Booth for your extra tickets.

AERIAL DEMONSTRATIONS

If you plan on flying in the show you **MUST** have an "Registration Number" assigned by the Airboss having jurisdiction over the show, or the airport owner. The FAA ATCT having jurisdiction, will have a list of those numbers, and may query pilots upon landing.

In order to fly during the show you **MUST** be at the pilot briefing prior to the show each day, and sign the waiver stating that you were at the briefing and want to fly. The Airboss will assign flight times for your flight. It is imperative that you have your plane fueled and you are at your aircraft, ready to depart at the designated time. Further information will be available.

FLY-BY ONLY

Aircraft wanting to do a "fly-by only" will need to fill out the Registration Form, be assigned a "Registration Number" and a specific time for the fly-by. This will facilitate the FAA ATCT and meet TFR requirements.
